Explanatory Note:

This amendment (this “Amendment No. 2”) amends Amendment No. 1 filed on February 16, 2016 on behalf of the reporting persons identified herein and EverPoint Asset Management, LLC (“EverPoint”) is being filed pursuant to Rule 13d-2(b) of the Securities Exchange Act of 1934, as amended, and reflects that EverPoint has merged with and into Point72 Asset Management, L.P., effective as of December 31, 2016. The reporting persons on behalf of which this Amendment No. 2 is being filed have executed a restated Joint Filing Agreement reflecting the removal of EverPoint as a reporting person with respect to this Amendment No. 2 and any subsequent amendments thereto, attached as Exhibit 99.1 hereto.

Pursuant to an investment management agreement, Cubist Systematic Strategies maintains investment and voting power with respect to the securities held by certain investment funds it manages. Mr. Cohen controls each of Point72 Capital Advisors Inc. and Cubist Systematic Strategies. As of December 31, 2016, by reason of the provisions of Rule 13d-3 of the Securities Exchange Act of 1934, as amended, each of (i) Point72 Asset Management, Point72 Capital Advisors Inc., and Mr. Cohen may be deemed to beneficially own 3,122,006 Shares (constituting approximately 2.9% of the Shares outstanding); and (ii) Cubist Systematic Strategies and Mr. Cohen may be deemed to beneficially own 11,686 Shares (constituting less than 0.1% of the Shares outstanding).
